


Dear Mr. Gamil,

At a properly noticed, and with a quorum present at the Advisory Neighborhood Commission 4C held on June 9, 2009, a motion by Commissioner Michael Yates was made to approve the request of Permit Tracking No. 47933. Carlos Iglesias of Bello, Bello & Associates LLC, located at 900 2<sup>nd</sup> Street, NW, submitted an application to occupy public space for the purpose of Paving: Driveway(s) New-Residential, Paving: Sidewalk(s) at the premises 5511 Colorado Avenue NW, Washington, DC 20011. The motion was seconded and passed with 7 in favor and 2 in opposition by the Commission.

The ANC suggests that Bello, Bello & Associates look at any safety issues that may impact pedestrians walking on the sidewalk.
